Sara Zeman Admin: Marine Exchange

The February 2025 Meeting of the Puget Sound Marine Firefighting Commission was called to order by Andy Collins at 1002.

Introductions followed.

BC Andy Collins began the meeting with a welcome and overview of the agenda.

Washington State Fire Training Academy Marine Program Update

Brian Smith provided updates on the restarting of the WA State Fire Training Academy Marine Program. Mollie Sundvik reported that re-using old materials and converting to a hybrid model are being worked on right now along with securing new materials and necessary updates.

Fireboat Zone Coordination Planning

Chris Perry with the Tacoma Fire Department, reported that the planning is moving along. Many agencies in the region are responding to marine firefighting incidents, but a standard process for coordinating those responses is being organized.

Russ Reed also added that the All Hazards Class is being updated, and Trish Jantzen shared that the Puget Sound Marine Firefighting Plan from the Northwest Area Contingency Plan is being updated and moving to a new plan location.

USCG National Marine Firefighting Task Force Update

Ish Looney reported that the updates are ongoing though Puget Sound participation is low. Looney will share the meeting schedule for those who are interested in attending and filling that gap.

Marine Exchange Update

Patrick Gallagher shared that vessel monitoring fees will be changing in the summer, and new funding options for the Puget Sound Harbor Safety Committee and Puget Sound Marine Firefighting are being explored. Gallagher also provided updates on the likely hosting of the National Harbor Safety Convention in Seattle during 2026.

IAFF/NTSB Workgroup Update

Aaron Patterson with the Seattle Fire Department reported that the workgroup met in DC last fall and was able to review and add to the incident report. The workgroup has since wrapped up and transitioned to organizing national training that has been grant-funded.

US Navy Marine Firefighting Drills Funding Update

Andy Collins with the Seattle Fire Department reported that the City of Seattle and the US Navy have been in contact about this funding and it should be finalized soon.
