The February 2026 meeting of the Puget Sound Marine Firefighting Commission was called to order by Andy Collins at 1102

Introductions followed

BC Andy Collins began the meeting with a welcome, introductions, and an overview of the agenda.

### **ONE Henry Hudson Fire Presentation**

Mike Oder provided an overview of the fire aboard the container vessel *One Henry Hudson* at the Port of Los Angeles. He described initial response actions, including the decision not to deploy firefighters below deck due to heavy fire conditions. The vessel was moved off the pier to anchorage due to smoke impacts and potential harbor disruption. Operational lessons learned: closely monitor fireboat water application rates, continuously assess vessel stability, and anticipate access limitations when operating at anchorage. Approximately 200 containers were affected by fire or firefighting water. Cargo uncertainty remains a challenge in container ship incidents.

### **Salvage and Marine Firefighting Subcommittee Proposal**

CDR Trish Jantzen briefed the group on Coast Guard Headquarters' direction to establish a joint salvage and marine firefighting subcommittee reporting to both the Area Committee and the Area Maritime Security Committee. She proposed leveraging the existing Puget Sound Marine Firefighting Commission structure rather than forming a new entity. The intent is to centralize marine firefighting planning, align with anticipated national planning updates, and strengthen integration among regional committees. Members discussed structural options and potential funding implications, including coordination with the Harbor Safety Committee.

### **GAO Review of Near-Shore Marine Firefighting**

Kelsey Hawley outlined GAO's congressional review of near-shore marine firefighting. The review examines the frequency and characteristics of marine fires, response challenges, interagency coordination, and Coast Guard oversight. Hawley invited regional stakeholders to participate in a February 17 information session and emphasized GAO's interest in first responder perspectives.

### **Marine Exchange Update**

Patrick Gallagher reported that the upcoming National Harbor Safety Conference in Seattle is sold out. Marine firefighting will be prominently featured on the agenda, reflecting significant national interest in the topic. He noted continued efforts to identify sustainable funding mechanisms for regional marine firefighting initiatives and discussed the potential for greater integration with Harbor Safety Committee processes to strengthen long-term support.

### **IAFF/NTSB Workgroup Update**

Aaron Patterson provided an update on the IAFF shipboard firefighting course developed from NTSB lessons learned. The curriculum is complete and currently offered as an in-person training. A future online version is anticipated, but the current delivery model remains instructor-led. Agencies interested in participation were encouraged to coordinate directly.

### **US Navy Marine Firefighting Drills Funding Update**

BC Collins provided an update on marine firefighting funding and coordination efforts, noting that Port Security Grant funding has been awarded and is undergoing administrative review. He emphasized the importance of continued regional collaboration and sustained funding to support training and preparedness.

### **Upcoming Trainings**

#### **Washington State Maritime Cooperative Marine Firefighting TTX**

Dan Smiley announced that WSMC plans to conduct its annual marine firefighting tabletop exercise in September 2026, pending final confirmation of facility availability. The scenario will involve a vessel fire and focus on unified command formation and salvage branch integration. Observers will be accommodated as space allows.

### **CLOSING REMARKS:**

BC Collins reinforced the importance of regional coordination, cross-agency planning, and continued training to strengthen marine firefighting readiness across Puget Sound.

The meeting adjourned at 1204. The next Puget Sound Marine Firefighting Commission Meeting will take place on May 19, 2026.
